On September 7, 2017, Equifax announced it was the target of a security breach which potentially permitted unauthorized access to the personal information of approximately 143 million U.S. consumers.

Steps you can take to protect yourself now are:

- 1. Change your passwords
- 2. Update your security questions
- 3. Use more than one email address
- 4. Keep monitoring your accounts
- 5. Equifax's link to identify your risk According to a report by ABC News, "The company established a website, equifaxsecurity2017.com, where people can check to see if their personal information may have been stolen. Consumers can also call 866-447-7559 for more information."
- 6. Credit Monitoring
- 7. Consider a "freeze" on your personal credit report
- 8.Report Identity Theft

#### **SMS Gaurdian**

At Heritage South Credit Union, we are always looking for the best possible ways to protect our customers and their money. Consider this fraud prevention made easy! Simply enroll your HSCU Visa debit, credit, and/or business card in the new SMS Guardian anti-fraud text alert notification service, which sends transaction alerts directly to your mobile phone or other SMS-enabled device.

#### What is SMS?

(SMS) Short Message Service is a text messaging service component of phone, web, or mobile communication systems, using standardized communication protocol that allows the exchange of short text messages between fixed line or mobile phone devices.

#### Here's how it works:

When a purchase that meets the monitoring criteria defined by HSCU is made with your card, a text will be sent to you for review. If you think a particular transaction is fraudulent, reply immediately. A SMS Guardian fraud analyst will block the card and follow up with you by phone. This added layer of security enables fraudulent activity to be identified and stopped immediately, which significantly reduces the likelihood that subsequent unauthorized transactions will occur. If you receive this message and the purchase is legitimate, do nothing. If the purchase is fraud, reply with the code provided within the text message and your card will be blocked. If you do not reply to the text message within 12 hours, the transaction is considered legitimate and no further action will occur.

#### How to sign up:

Visit www.MyHSCU.com, under the "loans" tab click "Visa credit cards" then click on SMS Guardian.


### **Same Day Notifications**

Effective September 15th, all financial institutions, including HSCU, will be required by Federal regulations to post electronic charges and deposits several times throughout the business day. In practice, this change means that charges which have previously taken 2-3 business days to withdraw from an account may now withdraw within minutes or on the same day as the transaction occurred. For example, an on-line payment, telephone payment, or electronic check may post on the same day that the transaction occurred.

HSCU also offers a variety of services that will make managing your account simple and convenient. Our mobile app, available for free on Apple and Android devices, is a great way to check your account throughout the day, and you can even deposit a check remotely through the app! We also offer text banking that alerts you when your account balance drops below a set threshold, which allows you time to call or log in to home banking, and check on your account activity.
